

GLACIERMETAL.COM PRIVACY POLICY

This Privacy Policy governs the manner in which GlacierMetal.com collects, uses, maintains, and discloses information collected from users (each, a “User”) of www.glaciermetal.com. This privacy policy applies to the Site and all products and services offered by Glacier.

PERSONAL IDENTIFICATION INFORMATION

GlacierMetal.com may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our site, place an order, fill out a form, and in connection with other activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, name, email address, mailing address, phone number, credit card information. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users may refuse to supply personally identifying information, however, this could interfere with the functionality of some Site-related activities.

NON-PERSONAL IDENTIFICATION INFORMATION

GlacierMetal.com may collect non-personal identification information about Users whenever they interact with the Site. Non-personal identification information may include the browser name, the type of computer, and technical information about Users' means of connection to the Site, such as the operating system and the Internet service providers utilized, and similar information.

WEB BROWSER COOKIES

GlacierMetal.com may use “cookies” to enhance User experience. User’s web browsers place cookies on their hard drive for record-keeping purposes and to track information. Users may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. Choosing to do so may cause some parts of the Site to function with difficulty.

How we use collected information

GlacierMetal.com may collect and use Users personal information for the following purposes only:

- ***To process payments via Bandcamp***
We may use the information Users provide about themselves when placing an

order only to provide service to that order. We do not share this information with outside parties except to the extent necessary to provide the service.

- ***To send periodic emails***

We may use the email address to respond to their inquiries, questions, and/or other requests.

HOW WE PROTECT YOUR INFORMATION

GlacierMetal.com adopts appropriate data collection, storage and processing practices, and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, transaction information, and data stored on our Site.

SHARING YOUR PERSONAL INFORMATION
